IV. BY-LAWS: On your copy of the Revised By-Laws for the League of Women Voters of Decatur, will you please note the following:

Your Local Board recommends upon suggestion of Mrs. Robert Phillips, President of the League of Women Voters of Illinois, that Article VI, Section 2, be changed from

"Annual dues of Three Dollars (\$3.00) shall be payable April first. Any member who fails to pay her dues within six months after they become payable shall be dropped from the membership rolls. Any voting member may present a request for a change of dues to the Board no later than the January Board Meeting. The Board must then notify the membership of the requested change, in writing, no later than one month previous to the Annual Meeting. It may or may not recommend the change. The change must be passed by a two-thirds vote of the members attending the Annual Meeting."

"Annual dues of Three Dollars (\$3.00) shall be payable
April first. Any member who fails to pay her dues
within six months after they are payable shall be
dropped from the membership rolls."

The reason for this deletion in Article VI, Section 2, is that any change in dues should be handled as a part of the regular amending procedure as stated in Article XII, Section 1, of the revised By-Laws.

V. PLATFORM:

Adequate appropriations, efficient administration, structural organization, and qualified personnel are subjects applicable to all the program and may be adopted for action in relation to any part of it. The platform represents principles supported and positions taken by the League in the past to which it has given sustained attention.

The Local Board may select items from the platform for action if an opportunity or necessity arises to do work in conformity with these principles. In case an issue has been inactive for an extended period, further examination and study by the local league members would be required before the Local Board could call for renewed action.

To promote knowledge of, and action for, the League of Women Voters of Decatur has concluded

- 1. That we retain the Special Charter for School District #61 with the possible exception of the section pertaining to size of the Board of Education, until the best interests of the school district deem otherwise.
- 2. That the Council-Manager Form of Government is preferable to the Commission Form of Government.
- 3. That we will continue to support a sewer system which provides all citizens of the Decatur Sanitary District with adequate sanitary facilities.

NATIONAL AGENDA

Item I: International Relations: The League's fiscal new year, April 1953, began with a study entitled "Trade or Aid?". At this time, G. F. Meyer, Chairman, and her workshop group considered the problems resulting from a continuance of our present tariff policy and those resulting from a possible change to lower or no tariff restrictions. In October, three members, Mrs. H. J. Pettee, Mrs. Wayne Dymond and myself, appeared on a local television program observing United Nations' Day. In this month, we began workshop sessions on "Making Foreign Policy". This subject with particular emphasis on the proposed Bricker Amendment was discussed in the Navarbar United "Making Foreign Policy". This subject with particular emphasis on the proposed Bricker Amendment was discussed in the November Units. A large majority of those members voting on the issue felt that the League of the US should oppose the Amendment. In January our National Board requested action in opposition to the Amendment. STATE AGENDA

Item I: Basic Constitutional Revision: a) Revenue: Since our strenuous and unrewarded efforts in behalf of the Revenue Amendment in the fall of '52, we have rested on this item. Review and further study will probably not be undertaken until '55. b) Court System: A summary of information to date will be presented in the April Units. Decatur League members appeared at every hearing on the Judiciary bills during the last session of the General Assembly. c) Re-apportionment: The first workshop is scheduled for March 10th with presentation of the material in the April Units. Following that we will work during the summer months to set up an organization for active community work prior to the vote Nov. 2nd. Item II: Home Rule: Since the State League wished to work also for statutory home rule should it be impossible to secure constitutional home rule, this item was separated from Item I at the last State Convention. Workshops will begin sometime in May and carry on throughout the summer months in order that we may be thoroughly grounded in the local forms of government. With this background, we should be ready in the fall to submit the home rule problems of this

LOCAL AGENDA

Item I: Decatur School District #61: At the Annual Meeting of 1953, we voted to undertake a "Study of the Budgetary Procedures and Tax Structure of the Decatur School System". After contacting every possible available source of information, we further compiled statistics from 20 school districts in 9 adjoining states in order to compare Decatur's financial operation. The next natural step in procedure was to turn our attention to the Special Charter and the State Laws under which we operate. We were hurried a little in this due to the petition to change the school district which was circulated early in November. Our conclusions from our financial study and from the laws are as follows:

1. By keeping the Special Charter we will avoid the possibility of lending ourselves to what appears to be experimentation going on at present where Illinois laws concern schools.

2. The wealth of the district appears to be above average for the size and is well directed in support of a good public school system.

Voters' Service on Item I: In connection with the Bond Referendum to build new school buildings, the League printed 10,000 "I can't vote-You Can" tags and distributed them to school children to take home to their parents. "Te also served as a source of information for the PTAs' in ways and means of getting information to the public and in getting out the vote. In connection with the petition, talks were made at Riverside, Pugh, Lincoln, Washington and Enterprise Schools, before the Education Council and will be made before the PTA Council, March 9th. A radio skit will be presented over the AAUW "Listen Ladies" program late in March and early in April.

Item II: Sewers: The first step in the Sewer program was brought to a successful conclusion with the passage of the Bond Issue May 26th, to build Interceptor Sewers. The third step, that of the individual neighborhoods building laterals, is well underway in affected localities. To date no action has been taken on the second step by the city, that of instituting a system of cleaning and maintaining all sewers within the city limits.

Publicity: The League's effectiveness in the community can be gauged, in part, by the willingness of press, radio and television to give us space to report our activities. WTVP arranged a program for us to explain the workings of the League; Mrs. Clifford Smith co-operated with AAUT in a UN program; and information about the Candidates! Meeting was given also. On the radio, Listen Ladies! time was twice available to the League, once for the economics committee to explain federal budgetary procedures, and, by the end of March, for the local project committee for their information on the school system. Also the stations are allowing the League to use spot announcements time for the Candidates! Meeting.

Besides the announcements of regular meetings, the paper also has been most generous when we have had special projects. In the drive to pass the referendum allowing interceptor sewers, the League and its members were continually in the papers. The report of the School Committee, showing the comparison of Decatur's budget and those of other towns, was printed. And there have been a succession of articles about the Candidates' Meeting.

TIME FOR ACTION ON NATIONAL ITEMS

Item I: The Reciprocal Trade Agreements Act, the basic trade law, expires in June 1954. It is time to WRITE Senators Douglas, Dirkson, and Congressman Springer NOW. Letters received before they have formulated their opinions are even more important than Calls for Action on specific legislation later on. The League's position is based on the following principles:
A. A U.S. trade policy should aim to expand World Trade rather

than contract it.

B. We have supported the Reciprocal Trade Agreements Program and the General Agreement on Tariffs and Trade as methods by which nations negotiate lower tariffs.

C. We have advocated a permanent international trade organization which would establish fair trade rules for all nations.

D. We have never advocated "free trade." We do advocate a gradual lowering of tariffs and the elimination of such barriers to trade as embargoes or quotas. We believe in a stable trade policy in the sense that once a tariff has been lowered it should not be raised when foreign products begin to compete with American products in this country. We are, therefore, opposed to the "escape clause" and the "peril point" provisions of our basic trade law.

E. We recognize that there may be times when foreign competition will inflict undue harm on a domestic producer. But the first consideration must be the national interest - that which is best for the total economy and our national security. When a domestic industry has been harmed, instead of raising the tariff or applying quotas, a readjustment of the industry to achieve greater efficiency or to diversify its products should be sought. Industries most closely concerned with national defense may require exceptional treatment.

If you agree with the majority League opinion as expressed in these principles, formulate your own individual letter in your own language and write PROMPTLY. Knowledge of the contents of the Randall Report will be of value to you. See below for the proper way to address your letters.

Item II. Now is the proper time to write Congressman Springer on Congressional Budgetary problems. Following are the points upon which a majority of League members have reached agreement:

1. Congressmen need a better opportunity to weigh the benefits of various proposals against their costs and to determine

the relative merits of such proposals.
2. Congress should have better methods for relating taxation

and spending measures.

3. In making authorizations, Congress should be able to appraise the total federal spending which will actually result through such legislative action. The inclusion of expenditure estimates in some authorization bills has been a step in the right direction. In making appropriations, the ultimate cost of a project or program should be pointed out clearly to the Congress.

4. Better coordination between the houses of Congress on bud-getary matters would save time, avoid duplication of effort

and lead to more informed deliberation on appropriation bills.

5. Congressmen should accept full responsibility for positions taken on appropriations. Roll call votes would make this information available to their constituents.

6. Congress should continually recognize its responsibility in improving its own procedures. When Congress sets up rules it considers to be good, it should either abide by them or change them. Citizens are confused by such practices in Congress as the attachment of legislative riders to appropriation bills, in spite of Congressional rules against such riders.

There is also agreement in the League on the desirability of granting the President the power to veto individual items in appropriation bills, if this proposal is combined with some of the more comprehensive changes outlined above.
